## DEMOLITION RULES

1. **POOR SPORTSMANSHIP AND BAD CONDUCT WILL NOT BE TOLERATED** at any time of the Demo Derby Event. If you or anyone associated with your car is involved in an altercation, the driver and all persons involved will be banned from the Demo Derby **FOR LIFE! NO EXCEPTIONS!!!**
2. All Drivers must have a legal current driver's license, and **MUST BE AT LEAST 18 YEARS OF AGE TO DRIVE A CAR IN THE DEMO DERBY EVENT. A copy of the driver's license is required with this entry. NO EXCEPTIONS!**
3. **ABSOLUTELY NO IMPERIALS.** No Convertibles, Vans or Pickups. T-tops must have roll bar and must be covered.
4. **CARS ENTERING HEAT RACES ONLY** MAY REPAIR THE FRONT END OR REAR END WITH OTHER THAN STOCK PARTS, BUT MUST APPEAR NEAR STOCK.
5. **ALL glass**, trim, metal, fender extensions, and anything breakable must be removed. All car preparation and anything flammable must be done prior to entering the pit area.
6. Wheel wells may be trimmed away larger bumper extensions may be trimmed. All cars will be free of broken glass and debris before inspection.
7. Batteries must be moved to driver's compartment in a sealed box. Radiators must remain in stock location, in front of engine.
8. All cars must have an H bar behind drivers seat. **NO EXCEPTIONS.** Roll bars are optional and driver's door must be reinforced. Doors must be secured by bolting, chaining, or welding.
9. The middle of the hood **MUST HAVE** a 2' X 2' OPENING.
10. Driver must have a helmet with chin strap and protective eyewear, which must be worn during all races and demo. Helmet must be strapped at all times.
11. **SEAT BELTS MUST BE ANCHORED TO FRAME UNDER DRIVER.**
12. Rear seat must be removed; BRAKES must be in good working order.
13. CARS will be pre-registered and numbered with your registered number. 150 slots are available.
14. **The Deadline for car entries is Monday, August 15, 2011 at 5:00 PM. \*\*\*NO REFUNDS WILL BE GIVEN AFTER CAR IS REGISTERED. \*\*\*\*\* NO EXCEPTIONS!!!**
15. Cars must be in self-starting condition at start of each race. All cars will have 18" high, visible numbers painted on both front doors and top of the hood. Number boards are preferred.
16. FIRE EXTINGUISHER MUST BE IN CAR, AND MUST BE SECURED WITHIN REACH OF DRIVER TIED DOWN WITH CLIPS. **NO PETS OR EXTRA RIDERS IN CAR AT ANY TIME.**
17. Women can enter either the heat races with the men, or enter the Powder Puff Race. Both men and woman may enter the Demo Derby Event.
18. Only the Driver is allowed in or on the car while it is on the track.
19. ONE TOW VEHICLE ALLOWED THROUGH GATE WITH EACH ENTERED CAR ONLY!!!
20. **Cars PREREGISTERING prior to Monday, August 15th will pay a FEE OF \$25.00 TO ENTER YOUR CAR. Late entries will only be accepted, Wednesday, August 17, 2011 at the Rodeo Office at the RODEO ARENA. An additional fee of \$20.00 will be added to each driver of the car. (Example: driver + powder puff = \$40.00 late fee in addition to the regular entry fee.) THE FEE IS \$20.00 TO ENTER THE POWDER PUFF CONTEST. ENTRY FEE MUST ACCOMPANY THE PERSON AT THE BACK GATE. No pit passes! Any other persons wanting to help with your car will be required to pay the price of a General Admission Ticket to the Demo Derby for \$15.00 each. Tickets will be available for purchase at the Green Gate.**
21. Australian Pursuit will be 10 cars per heat with \$20.00 entry fee.
22. **The top - four winning cars will be checked by officials. DEMO OFFICIAL'S DECISIONS WILL BE FINAL!**

### IMPORTANT NOTICE

Take note...Rules for Demo are final. Sandbagging or avoiding hard contact will be given one warning with a black flag. You will be disqualified on the second black flag. Pit Boss and Flaggers decisions will be final. **NO REFUNDS WILL BE GIVEN. There will be no alcoholic beverages allowed into the Demo Grounds.** NO coolers will be allowed. **There will be a no tolerance of open containers due to the beer garden and State regulations requiring security to be highly enforced. There will be absolutely no tolerance for poor sportsmanship and bad conduct.**

# RODEO CAR CONSTRUCTION

1. If you don't come with it clean you don't enter the pits or track area.
2. All cars will start the demo derby event with mud flaps behind the rear tires.
3. Bumpers must not extend past the fenders.
4. Welding is accepted from the A-arms forward on existing seams and joints. Not additional material will be added, with the exception of securing the engine.
5. Body bushings must remain in stock location.
6. Maximum of 6 3/8" bolts or 2 3/8" chain in front hood around bumper.
7. Maximum of 4 3/8" bolts or 2 3/8" chain in trunk around bumper.
8. Channel iron if used on car doors, edges must be trimmed. Techs discretion.
9. You may use chain or 2" strap to secure engine.
10. Absolutely no hump chains.
11. All cars must have a minimum of 2' x 2' hole opening in the center of the hood.
12. A minimum of 2' x 2' number board required on all cars with 18" minimum numbers in contrasting colors.
13. Anything that appears to be a safety hazard must be removed.

**If it is not in the rules you can't do it.**

# RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

**KWIQ and Moses Lake Roundup Demolition Derby**

**IN CONSIDERATION** of being permitted to enter for any purpose any **RESTRICTED AREA** (herein defined as including but not limited to the racing surface, pit areas, infield, approach area, shut down area, and all walkways, concession and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, **EACH OF THE UNDERSIGNED**, for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which he enters and with which he comes into contact, and he does further warrant that this entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgement that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted areas:

**1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE** the promoter, participants, racing association, sanctioning organization or any subdivision thereof, track operator, track owner, officials, car owners, drivers, pit crews, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as “releases”, from all liability to the undersigned, his personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating in, observing, working for, or for any purpose participating in the event.

**2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the release and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose in the event and whether caused by the negligence of the releases or otherwise.

**3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE** due to the negligence or releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or any purpose participating in the event.

**EACH OF THE UNDERSIGNED** expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. **EACH OF THE UNDERSIGNED** further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the State of Washington and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
